



Volunteer Income Tax Assistance Program (VITA)

The Volunteer Income Tax Assistance Program will be open at Rock Hill City Hall in the Wellness Center for **free** tax-preparation assistance. Volunteers are I.R.S. certified and trained by the SC & NC Dept. of Revenues—They are able to prepare the following forms:

- 1040EZ
- 1040A with Schedule 1, 2, 3, & EIC
- 1040 with Schedule A, B, EIC, & R
- 1040-V
- 1040-ES
- 2441 Child & Dependent Care Credit
- 8863 Education Credits
- 8812 Additional Child Tax Credit
- SC & NC State Income Tax Returns and other states
- Many more Tax Credits and forms not listed above

Free of charge, volunteers will electronically file federal and states income tax returns. It is fast, accurate, secure, and simple. **The estimated turn-around time for a direct-deposited refund is within days of efilng.**

- **Winthrop University** in the DiGiorgio Center 2nd floor each FRIDAY, 9am – 12:30pm, Feb. 2 thru March 30

What to Bring: Current year's tax forms--W-2 and 1099's. Information regarding other income. Information for all deductions/credits. A copy of last year's tax return. Proof of account for direct deposit of refund (e.g., voided check). Social Security or Individual Taxpayer Identification cards for you, your spouse, and/or dependents. Proof of identification for yourself and/or spouse.
