Upon receipt of the Final Payment, I do hereby waive, release and quitclaim in favor of the Owner of the Property and each and every party purchasing the Property or making a loan on the Property, as improved, and his or its successors and assigns, all rights that I may now or hereafter have to file a mechanics’ lien for any work included in the contract or agreement upon the land and improvements by virtue of the laws of the state of South Carolina. I further warrant that I have not assigned and will not assign my claim for payment, nor my right to perfect a lien against said Property, and that I have the right to execute this waiver and release, I further that all persons or entities supplying labor or materials to me, if any, for work upon the Property, have been fully paid, and that none of such persons or entities have any claim, demand or lien against said premises.

I further agree to indemnify and hold harmless Owner from any and all claims, lawsuits, causes of action, demands, or liens that may be filed by any subcontractor or material man with whom I have contracted for the provision of labor and materials concerning this project. Such indemnity shall include, without limitations, the obligation to reimburse Owner without limitation, the obligation to reimburse Owner for all costs or expenses, including reasonable attorney’s fees, associated with or necessitated by Owner’s defense against such claims, suits or liens.
