Things to Bring to Camp:

Our camp activities include things such as swimming, water slides, kayaking, archery, firearms shooting, paddle boats, fire-works, movies, outdoor games/sports, etc... Please bring clothing and shoes appropriate for a camp environment including a swimsuit. It is typically very hot during the camp so shorts and short sleeves are recommended. You will also need to bring either a sleeping bag or sheets and a blanket. The cabins are air-conditioned and you will be provided with a bunk bed/cot. We have shower facilities but you will need to bring your own toiletry items (shampoo, conditioner, soap, towel, washcloth, toothbrush, shower shoes, etc.). We highly discourage the bringing of any electronic items (cell phones, video games, I-pods, etc...) to camp. These items are easily damaged and we are very busy during the day so there is no time for their use. We are not responsible for any items that are lost or left while in your care. All food, snacks, drinks, etc will be provided so you will not need to bring any and food attracts bugs and animals to the cabins. It is recommended that you bring sun block and insect repellent if you would like to use these.

Other Important Things:

We thank you for your application for junior counselor. We expect you to interact with our campers and support our counselors in taking care of the campers. You will have some down time but you will be expected to participate in the activities that are scheduled. This is an overnight camp and you will be expected to stay the night with the campers and the counselors in the cabins. Any other questions will be discussed at the meet and greet that will be scheduled at a later date.
